ICAI functions under the administrative control of the Ministry of Corporate Affairs, Government of India. ICAI has its' headquarters in New Delhi, India. ICAI is the second largest professional body of Chartered Accountants in the world, with a strong tradition of service to the Indian economy in public interest.

During its existence of over seven decades, ICAI has achieved recognition as a premier accounting body not only in India but also globally, for maintaining highest standards in technical, ethical areas and for sustaining stringent examination and education standards. ICAI has a strong membership base of over 300,000 and around one million students.

### ICAI-Partner in Nation Building

ICAI, as a part of its role in aiding proactive process towards better governance, is called upon to interact with various regulatory/statutory authorities on issues of interest touching upon the profession and otherwise. In this process, the



Institute at regular intervals, provides technical advice and necessary inputs on matters of economic relevance and alike to various Ministries. It has enabled India as "One Nation One Tax" apart from numerous benefits like seamless credit across supply chain, development of common market, subsuming of multiple taxes into one basket, elimination of cascading of taxes etc.

## NARIC

We are pleased to inform that during the year ICAI qualification has been recognized by UK NARIC, The National Recognition Information Centre for the United Kingdom, a renowned UK national agency responsible to conduct an independent benchmarking study for evaluating the comparability of the ICAI Intermediate and Final levels in the context of the UK and UAE education systems. This will give an advantage to our students and members.

It would also provide opportunities for higher studies and enhanced professional opportunities for ICAI members/ semi qualified professionals in UK, Middle East and other foreign jurisdictions accepting NARIC evaluation.

## Organization

The affairs of the Chapter is managed by the Managing Committee which consists of Executive Committee, Leaders and Sub-committee members. Members of the Chapter elect the Managing Committee for a period of one year in the Annual General Meeting (AGM) till the conclusion of next AGM.

The Managing Committee is headed by the Chairman who is supported by other office bearers and sub-committee members. Executive Committee is responsible for identifying areas of interest to the members and organizing the events accordingly. Each member of the committee is allocated specified tasks and responsibilities which are well defined.

In order to pursue its objectives, the Chapter is well supported by Corporates, Banks, Business community and Professional organizations from UAE and Rest of the world. In return the Chapter provides various opportunities to the organizations by involving and partnering with them on the events organized by the Chapter.

## Activities

### Professional Development Events

## Examinations

Since 2007, the Chapter is facilitating examinations conducted by ICAI by making available the examination form to the students appearing in the examination and also nominates observers to look after the proceedings at the examination centres. Furthermore, the Chapter also organizes road shows at various schools to the students aspiring to take their career as a Chartered Accountant.

## Student Coaching

The Chapter has commenced coaching for CA Students from April 2016 with the first coaching being held for the Common Proficiency Test (CPT). This is a landmark development and will assist CA students in embarking on the journey to become qualified CA Professionals.



## Social Events

The Chapter organizes social events which along with entertainment provide opportunities to the members and their families to meet each other and bond their relationship. The key event is the Gala Dinner and Live Musical Concert.

In addition to this, the Chapter organizes get together for the members and their families that include desert safari, picnic, family outings, movie shows, various competition, cricket tournament and talent programs for members and their families.

The Chapter had organized 20 social events during 2019 and 7 events from Jan 2020 till 30th June 2020.

## Corporate Social Responsibility
